# **RENTAL TERMS and CONDITIONS**

### 1) RENTAL PERIOD [Term]

"Term" means the period from the time our equipment leaves our premises or is delivered to you (if you opted for delivery), to the date and time the equipment is due to be back in our possession. Unless otherwise agreed to by you and us (Triangle Party Rentals), the term will be deemed to be one (1) day (24 consecutive hours), commencing on the date and time you take possession of the equipment. Rented items must be returned within the specified rental period, otherwise an additional day will be charged for the items. Late return of rented items could impact the reservation of another customer, which will be considered in late return charges. This agreement will terminate when you return the rented items to us, together with all accessories, free from all damage and in the same condition and appearance as when received by you.

### 2) RESERVATION and RESERVATION DEPOSIT

To guarantee your rental items are available for your event date, a reservation must be made and a confirmation received by you. In addition, a reservation deposit of 25% of the total estimate of your rental items will be needed to hold the items for your event date. This amount will be considered as part payment of your rental items. The amount will be **non-refundable if reservation is cancelled within 72 hours of the start of your rental period.** If a rental deposit is not provided, then the item is not considered rented and may not be available for the day you requested.

# 3) CANCELLATION

- a) You may cancel this agreement without further obligation by delivering to us **written notice** of such cancellation at any time before 72 hours of your rental start time. Your 25% deposit will be refunded to you.
- b) For **Bounce House** reservations, you may cancel anytime if cancellation is due to inclement weather that may impact the use of the Bounce House. Rain forecast on the event date or windy conditions that would exceed 20 miles PH are considered grounds for cancellation and refund of the 25% Reservation Deposit.

#### 4) DELIVERY AND PICKUP

Except for the Bounce House that delivery, set-up, and pickup is **ONLY** done by us, you have the option to have us deliver other rental items. Delivery times and address will be agreed to during reservation. We deliver for a flat rate of \$25 within Prince William and Stafford counties. Any other locations will incur additional delivery charges. Pickup is also limited to the locations indicated above and it is additional \$25.

#### 5) OTHER TERMS and CONDITIONS

The above terms and conditions could be adjusted based on the specific needs of the moment. In such cases, additional conditions will be appended to this agreement and signed by both parties. The Bounce House has separate rental conditions that are not indicated in this agreement.

By signing below, you agree to this rental agreement with the expectation that all the terms will be binding upon us. You also agree that in the event of any issues arising from the agreement, you and Triangle Party Rentals will first have a mutual conversation to resolve any such issues and then escalate to a third party mediation/Arbitration process if not resolved. Litigation will be the last option if mediation fails.
